1. Call the meeting to order

Magistrate Popp called the hearing to order at 3:00pm.

2. Roll Call

City Attorney Drew Smith and Clerk to the Magistrate Michele Ficocello.

3. Approve Minutes

5. Request To Identify Persons Having Cases on The Agenda

6. Parking Citation Appeals

- a. P01792FB; Geoffrey Garcia; Officer M. Guerrero # 7055

Item was moved to 6c. The Appellant was present and sworn in by the Clerk. The Officer was not present. The Appellant testified he was in the City during a parade and a City Officer instructed him to park where he did. The City Attorney stated that since the Officer was not present, the City could not rebut the testimony. Magistrate Popp ordered the citation dismissed.

- b. 3135; Teresa Cordeiro; Corporal A. Barkoskie #796 (FCSO)

Item was moved to 6a. The Appellant was present and sworn in by the Clerk. The Deputy was not present. The Appellant testified she believed she was parked correctly and did not know she had a citation until after driving away. The Appellant submitted photographic evidence into the record (attached to the minutes). Discussion ensued related to the way the Appellant parked. The City Attorney stated the FCSO Deputy is not present to rebut the testimony and the City would accept a dismissal. Magistrate Popp ordered the citation dismissed.

- c. 3133; Lucas Teter *Telephonic Appearance*; Corporal A. Barkoskie #796 (FCSO)

Item was moved to 6b. The Appellant was present via telephone and was sworn in by the Clerk. The Deputy was not present. The Appellant testified there was construction by South Third Street and it was during Labor Day weekend. The Appellant stated his vehicle was parked facing towards Sate Road A1A and facing the wrong direction on a one-way street. Discussion ensued related to the way the Appellant parked. Magistrate Popp determined, based on the evidence, the Appellant did commit the parking violation and explained safety concerns with parking in the wrong direction. The City Attorney stated, based on the circumstances, alternative remedies would be an option. After discussion, Magistrate Popp ordered the Appellant to perform a beach cleanup on his own and submit the affidavit along with evidence to the Clerk.

- d. P01921FB; David Dehlin *Telephonic Appearance*; Officer E. Luttrell # 7089

The Appellant was present via telephone and was sworn in by the Clerk. The Officer was not present. The Appellant testified that the cost of the citation would create a hardship and stated he was parked on private property. Discussion ensued related to the way the Appellant was parked. Magistrate Popp explained the safety concerns with parking in the wrong direction and based on the evidence it was determined the Appellant committed the parking violation. The City Attorney recommended a dismissal with an understanding to educate other licensed drivers. Magistrate Popp dismissed the citation and the Appellant agreed to educate other licensed drivers.

9. Other Business

The Clerk reported there are no Code Enforcement cases scheduled for the November hearing date, but there are possible parking citation appeals. Discussion ensued related to choosing a hearing date in December and canceling the November hearing. The tentative hearing date is December 10th at 3:00pm. The Clerk will follow up with more details. The Clerk inquired about implementing a filing fee for parking citation appeal requests. The Clerk will provide the background information, and the City Attorney will discuss it with the City Commission and report back. The City Attorney provided an update on the 1201 S Central Ave code enforcement case.

Magistrate Popp adjourned the hearing at 4:46pm.

Dear Magistrate,

I received the enclosed ticket on Friday, October 10, 2025. It is under my husband's name. However, I was the one who was driving. This is going to sound like a sob story but this is a true accounting of my life. I will be 74 next month, on social security and still working from home to make ends meet. In the past five years or so, my husband has had two knee replacements, hernia surgery, Prostate Cancer, two major back surgeries, a wire stimulator inserted in his back, Lung Cancer where he had his whole right lung removed, emphysema, COPD, neuropathy, skin cancer and frontotemporal dementia. I am his sole caretaker. I don't get help from his family or from anyone else. I am only able to go out once a week to help my daughter with her baby. Otherwise, we do not have a social life because of his illnesses.

One of my best friends turned 75 and I wanted to treat her to lunch. Again, this is something that I'm not able to do on a regular basis but I asked a neighbor if she would be on call in case my husband needed anything. We went to Romanos Tuscany restaurant and waited for over ten minutes to be seated. No one came, so we left. I was trying to go somewhere else close so as to not waste time leaving my husband home alone for a long period of time. I decided to go to Next Door Beach Bistro. I had to circle around a few times to find a parking space. It was raining and when I finally did and I know that this is not a valid excuse but the car in front of me was parked in the same direction so I followed suit not realizing that it was wrong. When we came out, we saw the ticket on my windshield and there were two different vehicles parked in front of me so I'm not sure if the first car was ticketed also. I was shocked when I saw the amount of the fine as it will take me over 6 ½ hours of work to pay it.

I know this is long winded. I realize that I parked in the wrong direction and learned my lesson to be more aware of the situation but I'm asking because of all the stress that I am under and this being an isolated incident of being out of the house for just a couple of hours, that you would be kind enough to just give me a warning. I can supply medical documents if you need to substantiate my husband's condition.

I appreciate your time in reading this. Can someone please contact me by phone, text or email to let me know the final outcome of your decision.
