4. Approve Minutes

a. January 6, 2026 Meeting Minutes

A motion to approve the meeting minutes was made by Scott Chappuis, seconded by Paul Mykytka. The motion carried unanimously.

5. Old Business - None

6. New Business

- a. Final Site Plan Application PMS26-0002: Flagler Beach Vacation Rentals, 1708 S. Ocean Shore Blvd.; Parcel ID: 18-12-32-2750-00030-0030; Applicant: Theodore Barnhill; Request for final site plan approval to construct a three-story, eight-unit, oceanfront vacation rental apartment building in the Tourist Commercial Zoning District.

The City Planner presented the item and staff report. The applicant was present and spoke before the Board which included a power point presentation. Board discussion ensued and included business type classification, parking requirements, short-term rental regulations, hotel/motel requirements related to the project, recreation requirement per the land development code if the project is classified as a hotel/motel, Suntrail project and purchasing rights-of-way, masonry wall requirements, sanitation requirements, alley maintenance, the site plan meeting the requirements of the land development code, the role of the PAR Board as it relates to this site plan review, the City Commission will also review the site plan, legislative vs recommendation board, minimum parking stall

requirements and occupancy. The applicant stated the state of Florida classifies it as transient lodging and there are locations on the plans which satisfy the recreation requirement. Public comment was opened. Andre Delany, 1735 S Central Ave, comments included required studies being conducted, occupancy, parking, alley maintenance responsibility and sanitation. Clark Jones, 1710 S Central Ave, comments included two-bedroom unit vs one bedroom unit requirements and parking stall sizes. Mike Archer, 1702 S Central Ave, comments included sanitation, access to alley concerns, mailbox access concerns, construction concerns, parking concerns, clarification for classification of proposed business and life safety concerns. Charles Balassone, 1705 S Central Ave, comments included concerns related to a propane tank in his backyard, alleyway concern and sanitation concerns. Laurie Hagan, 1702 S Central Ave, comments included concerns about the high density of the project. Cindy Seer, 1731 S Central Ave, clarification on the project classification and building in the setback concerns. No further comments were received. Public comment was closed. The applicant addressed the concerns raised during public comment and expressed his willingness to resolve them. The applicant explained many of the concerns raised during public comment will be addressed through the building permit process. The City Planner stated the applicant is willing to work with the City to address the alley concerns and regardless of the business classification, the project is a permitted use meeting the requirements of the land development code.

Lisa Smith made a motion to recommend approval of item 6a.; Scott Chappuis seconded. Motion passed unanimously after a roll call vote.

8. City Planner Report

The City Planner reported she will be forwarding the mobility study plan draft to the Board. Ms. McClenning attended the Northeast Florida Regional Council Planner's Meeting and the NEFRC will provide a workshop training for the PAR Board. The City's Comprehensive Plan Amendment was approved, and an Evaluation & Appraisal Report (EAR) is not required, but mapping updates are required. Legislative updates will be forwarded to the Board.

Background Project Summary:

In August of 2024, applicant Jeff Ryan of 12 Bishop Lane, Palm Coast, FL 32137 submitted site plan/concept plan to redevelop the golf course. The project proposed an expansion of existing parking lot, construction of a new clubhouse, and re-grading the existing golf course.

Clubhouse

Gross Area: 30,000 SQFT

Floor Area: 15,000 SQ FT

Uses: Golf Shop, Clubhouse, and Restaurant

Site Plan

A major site plan is required for new non-residential structures, including the clubhouse and parking.

A pre-application meeting was conducted with applicant’s engineering firm, McKim and Creed of Tampa, FL.

The site plan submitted includes required cover sheet, project title and location, general site plan information for applicable elements including the overall building square footage, its location and parking calculations.

The site plan sheet includes required property dimensions, legal description, total gross acreage, zoning district and adjacent property.

Additionally, location of existing and proposed stormwater management system, proposed practice putting greens, and proposed putting tee and tee boxes are identified on the site plan along with adjacent property within fifty (50’) feet perpendicular to property lines are noted.

The site plan identifies location of existing trees, and proposed landscape area.

Total site area is +/- 42.93 acres.

42.39 * 43,560 SQ FT = 1,846,508.4 SQ FT.

Clubhouse

In accordance with the land development code, operators of buildings of the same uses requiring off-street parking facilities may take collective provision for such facilities, provided that the total of such parking spaces when combined or used together are not less than the sum of the requirements computed separately.

Staff Recommendation

**ORDINANCE 2026-04
OCEAN PALMS GOLF COURSE REZONING**

AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF FLAGLER BEACH, FLORIDA, AMENDING THE OFFICIAL ZONING MAP DESIGNATION FOR APPROXIMATELY 2.943 ACRES OF CERTAIN REAL PROPERTY; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City Commission of the City of Flagler Beach, as the governing body of the City, pursuant to the authority vested in Fla. Stat. Chapter 163 and Chapter 166 and the City of Flagler Beach Land Development Regulations, is authorized and empowered to consider applications relating to zoning; and

WHEREAS, the City of Flagler Beach is in receipt of a request to amend the City's Official Zoning Map for the property described herein; and

WHEREAS, the above-referenced property is presently zoned Medium Density Residential (MDR) and the request is to have the property rezoned as Recreation (REC); and

WHEREAS, the request is in accord with the Future Land Use Map designation of the subject property, and is compliant with all applicable Objectives and Policies of the City of Flagler Beach Comprehensive Plan; and

WHEREAS, the Planning and Architectural Review Board has recommended the City Commission change the Official Zoning Map to reflect a new designation for the subject property as Recreation; and

WHEREAS, the City Commission has considered the findings in the staff report and the following findings of fact:

1. The rezoning is consistent with the purposes, goals, objectives, and policies of the City of Flagler Beach Comprehensive Plan;
2. The rezoning is compatible with the Land Development Regulations, and generally consistent with the uses and character of the land surrounding and in the vicinity of the land proposed for rezoning;
3. The rezoning will result in a logical, timely and orderly development pattern; and
4. The staff report has demonstrated sufficient justification that there are changed circumstances, which would require the rezoning request.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF FLAGLER BEACH AS FOLLOWS:

SECTION 1. LEGISLATIVE AND ADMINISTRATIVE FINDINGS. The above recitals are hereby adopted as the legislative and administrative findings of the City Commission of the City of Flagler Beach.

SECTION 2. OFFICIAL ZONING MAP AMENDED. The approximately 2.943-acre subject area generally located at 3600 South Central Avenue, Flagler Beach, Florida 32136, with Flagler County Tax Parcel ID No. 29-12-32-0000-01010-0010, as legally described in **Exhibit A** attached hereto, is hereby amended from the City of Flagler Beach designation of Medium Density Residential (MDR) to Recreation (REC).

SECTION 3. CONFLICTS. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION 4. SEVERABILITY. If any section, subsection, sentence, clause, phrase, or provision of this Ordinance is held to be unconstitutional or otherwise invalid by a court of competent jurisdiction, such unconstitutionality or invalidity shall not be construed as to render unconstitutional or invalid the remaining provisions of this Ordinance.

SECTION 5. EFFECTIVE DATE. This Ordinance shall take effect immediately upon passage as provided by law.
